

CHAPEL: The board continues to discuss the prospect of building a new chapel. Michael Mietlicki shared design ideas that have been compiled. The board was very engaged in discussing ideas and areas to build it.

PROJECT UPDATE: Paul Gorgol reported on the following

- a. Meeting with Architect, Pat Endler was held Saturday, February 12. The Facility was reviewed as is and then what changes can be made. Revised drawing will be made for review of changes. Next meeting is scheduled for the end of March. Bids should go out in July with the start of renovations in the fall. Paul Kaspriskie will be project manager. Project could cost up to \$200,00.
