## PNU Board of Directors Visit NEPA Shelter

On December 8, 2022 after the regularly scheduled meeting of the Board of Directors the members visited the Northeast Pennsylvania Youth Shelter. This visit was to present to the shelter a new refrigerator for water and a stack of gift cards to local fast food restaurants for the at risk youth. The Board of Directors at their October 2022 meeting decided that this year in lieu of the annual Board Christmas



Party we would perform a fraternal activity instead.

Vice-President Kathryn Nemkovich was tasked with finding an appropriate non-profit organization in the Scranton area that was in need of items. After researching the need it was determined that the NEPA Youth Shelter was the group chosen.

The NEPA Youth shelter provides numerous opportunities for at risk youth in the Executive Scranton. The Director Maher-Gray informed the Maureen Board that they were desperately in need of a new refrigerator to hold water bottles. The current refrigerator had failed and could not hold the 100 bottles necessary for the shelter. The PNU purchased this item and had it shipped to the shelter. The Board also decided to



provide the shelter with a number of gift cards so that the Director could pass them out for the children to have food.

District Director Julie Andrzejewski called the meeting to order at 7:16pm on September 7, 2022. The meeting was held at Good Shepherd parish in Plymouth, PA. Rev. Carmen Bolock had the opening invocation. Director Andrzejewski announced that Jessica Moser would be stepping down as Recording Secretary. She stated that Joan Scheuneman would step down as Vice Director to take over the Recording Secretary position and that Mari Jane Stankowski agreed to take over as Vice Director. She then appointed Mari Jane Stankowski as Vice-Director and Joan Scheuneman as Secretary.

<u>Secretary's Report</u>: Attendance: Secretary Joan Scheuneman reported that there were 9 delegates representing 6 branches and 6 guests present. Ms. Scheuneman then read the minutes from the previous meeting. Director Andrzejewski asked if there were any corrections or errors and there were none noted. The biggest change in the application is that there is a new "leave behind" page which is to be given to the applicant at the time they sign up for a new insurance certificate. This is to comply with HIPAA regulations. She also explained the necessity of completing the section asking if an individual has other insurance coverage as this is important information as to the issuance of the certificate. A brief question and answer session followed.

<u>Old Business</u>: A report was given regarding our Family Day at Skyzone. We mailed 119 postcards and posted information in all the local parishes. In total there were 3 children and 7 adults that attended. We may try a movie later this year to try for a more highly attended outing. Vice Director Mari Jane Stankowski brought information regarding a possible fraternal project. St. Stanislaus Parish has re-started it's One Hot Meal program.

# Polish National Union of America District 6 Quarterly Webinar/Teleconference Meeting October 25, 2022

The meeting was called to order by Director Christine Wachna at 6:35 p.m. The Invocation and prayer for healing for Teri Heath and for deceased secretary Dr. Walter Cegelka was pronounced by Very Rev. John P. Kowalczyk.

Director Christine Wachna called the Roll: **Present**: Director Christine Wachna; Very Rev. John P. Kowalczyk; Catherine Kowalczyk; Christina Danielkiewicz; Judith Palacios; Robert Maycan. **Absent**: Rt. Rev. Jarosław Rafalko; Rev. David Rowinski; Teri Heath; Dian Maycan. Guests at meeting were Martin H. Wachna, PNU CEO; Judith Wachna.

The **Agenda** as presented was revised adding that Christina Danielkiewicz would report on points presented at the General Synod. The **Proposed Revised Agenda** was accepted as presented upon motion made by Catherine Kowalczyk and seconded by Robert Maycan. Motion carried. The **Minutes** from the August 18, 2022 meeting were accepted as presented upon motion made by Very Rev. John P. Kowalczyk and seconded by Catherine Kowalczyk. Motion carried.

The **Financial Report** for the 3<sup>rd</sup> quarter of 2022 was given by Catherine Kowalczyk. Upon motion made by Robert Maycan, and seconded by Christina Danielkiewicz, the financial report was accepted, subject to audit. Motion carried.

**Remarks from District Director Christine Wachna**: Christine stated that the 5 for 125 Program presently in force will likely be the last Open Enrollment.

It was reported that 2 clergy from the Western Diocese signed – the clergy policy. Fr. Sr. John Kowalczyk stated the Diocese pays for \$10,000 and the remainder is responsibility of the clergyman or the parish. If the parish does not assist, it is the responsibility of the priest.

The 2022 Irene Jugan Heart and Soul Award was presented to Christina Danielkiewicz. The recipients of this award for the last four years (since its inception) were all delegates to the recent XXVI General Synod, therefore the PNU felt it appropriate to present all four recipients their award at the Synod. 2019, Henrietta Kleckner; 2020, Christine Wachna; 2021, MaryJane Stankowski; and 2022, Christina Danielkiewicz. The 2022 recipient was announced on Spójnia Sunday.

#### **Old Business**

**"5 for 125" Program -** This program started August 1, 2022 and will run thru December 31, 2022. The program is a 5 Pay Life Policy for either \$5k or \$10k. The program is Open Enrollment for ages 25-80 with no medical. All Districts are encouraged to sell five policies in this program.

Spójnia Sunday - Christina Danielkiewicz attended Mass on September 24, 2022 at All Saints Cathedral. Following Mass Christina was introduced by Robert Maycan, President of Br.37 to give remarks on Spójnia. She highlighted the 5 for 125 Program and encouraged members to increase their insurance coverage or if they have no insurance, to take advantage of this Open Enrollment program.

#### **New Business**

**Branch Secretary Reports: Br. 37 and Br. 362**: Director Christine Wachna reported on these two branches. Br. 37 is without a secretary right now. Br. 362 will need to elect a secretary following the death of Dr. Walter Cegelka, the branch's long serving secretary. As of now Director Wachna is overseeing both these branches. Robert Maycan is to obtain the Branch 37 records from Rev. David Rowinski. Rev. Rowinski was removed as the Interim Secretary. CEO Martin Wachna reported he is working on getting a replacement for Branch 37. Also CEO Wachna will be speaking with Judith Palacios asking her if she would be willing to serve as Br. 362 secretary.

**Branch Br. 295 – Catherine Kowalczyk:** Cathy reported that she signed two Social memberships and has five policies pending.

**Br. 293 - Christina Danielkiewicz:** Christina reported that she is trying to sign members for the **5 for 125 Program**. Also she has made contact with a few members (met with them while visiting the Chicago area) regarding updating their addresses and asking about change of beneficiary. She informed the members that the change of beneficiary form is a "downloadable" form and can be printed, signed and sent to the Main Office. She requested the members to send her a copy of the updated address form.

Christina Danielkiewicz was called upon to give **information from Spójnia announced at the XXVI General Synod** that took place October 18-21, 2022.

- Annuity rate is now 3.75% through 12/31/22. This is only for new monies received.
- The Family of John & Dorothy Markiewicz is initiating a scholarship focusing on healthcare. It will be \$1,000 annually. More details will appear in the December Straż.
- Elaine Gazda, the sister of the late Ernest J. Gazda, Jr., is funding a scholarship in Ernest's name. Mr. Gazda served for many years as attorney for the Polish National Union of America.
- Spójnia's new website will be up effective January 1, 2023 and an App for Smartphones is in the works.

Activities for 2023 – It was stated the smaller attendance over the past few years attending the Wolves hockey games has indicated that this activity has "run its course". Other ideas brought up were WNBA game, but need to check prices, dates, etc. They play at the Sears Center in Schaumburg, IL. Another possibility is a bowling event. We could call it "Up Your Alley", a pizza and bowling outing. Another idea during spring or summer is a minor league baseball outing. Possible teams are Joliet Slammers; Chicago Dogs; Gary Railcats. Information would be needed before planning such outing.



# Report of Actions Taken by the Board of Directors of the PNU during a special board meeting held November 18, 2022
