2023: The Year of Transformation Update

The Board of Directors and Management Team report that the "2023 Year of Transformation of the PNU" continues to move forward. The process now is the agreement between the PNU and the PNA has been reached. The

agreement has been drafted by the attorney for the PNU and has been presented to the leadership of the PNA for review.

Once the documents have been reviewed each board will need to approve the terms of the agreement. Then a notice will be placed in the Straz for the members of the PNU to review and provide comments directly to the Home Office. This notice will remain in effect for 60 days. The Board of Directors of both organizations will then submit to the conventions of each organization the agreement in order to ratify the decision of the Board of Directors. The PNU will use the members of the 2019 Convention for ratification.

The mission of the PNU continues and the Board of Directors continues to position itself to be strong for next 115 Years. These are very exciting times in the PNU and you the member are going to be the ones that benefit from this transaction.

Please continue to purchase new policies or annuities during this time as they will all become a part of the merger. **More** Benefits, **more** types of Policies, **more** types of Annuities are what your Management Team and Board of Directors are doing for you.

Polish National Union of America District 1 Quarterly Meeting March 16, 2023

Due to low product sales and rising regulatory costs, the Board of Directors arrived at this course of action. The Board has been in negotiations with eight other fraternal organizations and will be down-selected to three viable candidates in the near future.

During the negotiation process, insurance and annuity sales will continue as usual. Anything that we sell now will be honored and remain in force through the merger. After the merger, the PNU

will be known as the Polish National Union Foundation. Budgets will then need to be supported through fundraising events.

The PNU has been focusing on fraternalism. Order of Business is to involve the PNCC parishes in District 2 to become involved in activities from each parish or via joint effort to demonstrate fraternalism. Not necessarily by sending in money, but showing acts of fraternalism in supporting those in need.

e.g., will be helping people in need, such as a: Food drive/clothing drive, Food pantry, Collect baby items to present to a shelter for women, Create hand-made prayer blankets, Meet with parishes every quarter to create a plan.

It was mentioned that Fr. Joseph Cyman's parish sponsored a free picnic open to the town and also sponsored Children's Day with fun activities including a magician for all children present.

District Director indicated that there will be no Convention of the Polish National Union of America this year due to the ongoing transformation. Any type of Convention will most likely be held in Scranton. Delegates will be the same as the 2019 convention.

Edmund J. Kotula, Past President and CEO of the Polish National Union, received a Certificate of Appreciation for his many years of service and dedication to the Polish National Union from the Board of Directors. The award was presented to him by his daughter, Leslie Pietrowitz, District 2 Director at an in-person meeting held in Wallington on March 23, 2023.

In researching Spojnia archives for the centennial celebration in 2008, a unique discovery was made of a rare situation that occurred in the organization. A father and son each served as President of the Polish National Union of America. The Kotula family was represented in the office of President by Stanley S. Kotula from 1953 to 1966, and Edmund J. Kotula from 1995 to 2007, totaling more than 25 years of service.

At the twenty-fifth quadrennial convention of the Polish National Union held in 1995, Stanley's son, Edmund, was elected to the Presidency. Prior to his election to office, Edmund served as Secretary of Branch 162 and has served as District Director, New York-New Jersey. He was a member for 20 years of the Controlling Committee as well as 16 years as member and Chairman of the Fraternal Activities Committee until his election to office as President.

During his years of service to the Polish National Union, Edmund welcomed many members, counseled many Branch Secretaries and organized many fraternal events. During his tenure, several trips were organized to Poland with members of both the Polish National Catholic Church and the Polish National Union visiting prominent cities throughout Poland as well as the Polish Catholic Church. One event, which stands out as truly unique in the history of the PNU is the recognition of our organizer and founder, Prime Bishop Francis Hodur at Ellis Island. These acts are truly living the spirit of Fraternalism.

Edmund and his wife, Peggy, currently reside in Wallington, New Jersey and are members of the Transfiguration of Our Lord Parish. They have three married children Leslie, Amy and Edmund Ned, as well as seven grandchildren. All are members of Branch 162 in Wallington, NJ. Edmund continues to serve our fraternal as Branch Secretary of Branch 162 and continues service on the Supervisory Committee to the Spojnia Credit Union.

POLISH NATIONAL UTION OF AMERICA POLICY NOTICE

Polish National Union of America Privacy Policy Notice

The Polish National Union of America (The Society) is a member driven society, which is highly dependent upon the confidence each individual has in its purpose. One of the most essential elements of the member-society relationship is privacy.

Privacy is and always has been the number one priority of The Society. Keeping with this tradition, the following notice is intended to inform you about the information the society collects in the process of providing insurances services and member benefits.

"Nonpublic personal information" (NPI) is defined as nonpublic information about you that The Society obtains in connection with providing an insurance or annuity product to you. Examples of NPI include amounts of insurance, premium payment, and beneficiary designations.

Information Collected by The Society

Information submitted by you on applications for membership, insurance coverage and claims.

Information submitted by you and documents associated with the many fraternal programs established by The Society, (E.G Scholarship programs and stipends).

Information received by The Society for underwriting processes. This information is generally obtained from sources such as personal medical records, society required exams, and other third-party consumer reporting agencies.

Information Disclosed by The Society

The Society is permitted by law to disclose NPI to nonaffiliated third parties that assist in processing of data and the servicing of accounting records for the purpose of carrying out main business. The Society is also obligated to disclose this information to government entities during periodic mandatory audits.

There are certain third-party affiliates associated with the Polish National Union which from time-to-time NPI is shared in order to provide additional benefits to you. The third parties include The Straż, Spójnia Credit Union, Inc., Fraternal Activities Committee and The Education and Youth Committee. The Society does not disclose any NPI about you to any other third parties, except as permitted by law. Information shared is derived from that which is collected during the many application processes administered by The Society as described in the section entitled "Information Collected by the Society."

Procedures For the Preservation of Your Privacy

As a fraternal benefit society, The Polish National Union of America has held membership privacy as its highest priority since the start of business in 1908. Since then, many procedures and safeguards have been developed to ensure that this priority is maintained. Among them are:

1. Training of personnel regarding the recognition of NPI and proper authorization for release of that information.

2. Limiting record access only to those Home Office employees who are working with your file.

3. Requirements that all requests for information be signed in original with a proper witness.

4. Establishment of board policy requiring the immediate dismissal of any employee who divulges NPI without proper authorization.

5. Establishment of policy restricting the distribution of NPI to those third parties permissible by law only. Your NPI is protected by board policy which regards all information as private and therefore not for sale or for use by any nonaffiliated third parties. This policy also extends to former insureds who no longer have a customer relationship with The Society.

As a final note, please be assured that the information in our insurances files will always be available for modification, corrections, or change when appropriate.
