Final Announcement

The Board of Directors and Management Team of the PNU and the Polish National Alliance are excited to announce the merger agreement of the two organizations have been signed and submitted to the Commonwealth of Pennsylvania and State of Illinois for approval.

- August 18, 2023, Very Rev. John Kowalczyk Chairman of the Internal Audit Committee, Mrs. Carol Mikovsky Delegate to the 31st General Convention, Mrs. Katherine Gnat PNU Member at large gathered at the offices of the PNU to count the ballots submitted for the approval of the merger of the PNU with the PNA. Upon the completion of reviewing and counting ballots it was determined that the vote for the merger passed unanimously.
- August 29, 2023, CEO Wachna and CFO Andrzejewski attended the 49th Quadrennial Convention of the PNA. At the convention President/CEO Spula addressed the delegates and explained to those present the terms of the merger. Once Mr. Spula concluded his remarks he asked CEO Wachna to address the convention. Upon the conclusion of CEO Wachna's remarks the Chairman of the Convention called for a vote on the resolution to agree to the merger. The merger vote was unanimous for the PNA as well.

- On September 5, 2023, the attorney Todd Martin for the PNU filed all the documents with the Commonwealth of Pennsylvania and the State of Illinois. The status of the merger is scheduled to complete on October1, 2023 upon receipt of the approvals.

The leadership and delegates of the PNA are excited that the PNU has chosen to merge with them. They are looking forward to the continued partnership in the future. The Board of Directors of the PNU, The Supreme Council of the PNCC and the Management of the SCU look forward to a long and prosperous journey with the Polish National Alliance.

Straz Publication Announcement

The Polish National Union of America is saddened to announce that the September 2023 edition of the Straz will be the final edition printed by the Union. For the past 115 years the Straz has been the official publication of the PNU. Eleven years prior to that, the Straz was the official publication of the Polish National Catholic Church.

On August 29, 2023, the Polish National Union signed the final documents to merge with the Polish National Alliance. As the PNU transitions to the PNA the official publication of the PNA is the Zgoda. In the merger agreement, the PNA agreed to return the Straz back to the Polish National Catholic Church.

Currently, Prime Bishop Mikovsky along with the Supreme Council of the PNCC is determining how and when the Straz will be published. While the Straz has been continuously printed for the past 126 years the future editions are yet to be determined, so stay tuned.

The Board of Directors of the Polish National Union of America wish to thank all the members, Districts, advertisers, and those who submitted articles and announcements for the past 115 years.

A Marker in History

This publication marks the final publication of the Straż produced by the Polish National Union of America as our Fraternal Benefit Society prepares to join with The Polish National Alliance by means of a merger. As such September 30, 2023, will mark the point at which the history of the PNU

turns the corner to continue in service to the loyal members who are the Society. This time is not a time to weep in sadness but rather a time to look at the many opportunities that lie before our membership to avail themselves of the many benefits that our new and larger Fraternal Benefit Society has to offer.

I stress that this time is a marker in our history. The remainder of the story that is told is truly up to each and every one of the individuals who have belonged and supported the PNU through its 115 years as an independent Fraternal Benefit Society. The new beginning is not the end of the story as preparations have been made to ensure that the good work being done to be our "Brothers and Sisters" keepers continues into the future. A new district specifically dedicated to the PNU has been established to keep our Branch structure intact and functioning. This structure will allow the PNU to be identified throughout the new Fraternal Benefit Society.

The following is an excerpt from the letter I wrote for our 100th anniversary book which I wanted to include as an appropriate reminder of the rich history we have shared with the world.

"There is a time for everything and a season for every purpose under heaven..." (Ecclesiastes 3:1).

One hundred years ago there was a time in which all the ingredients necessary to precipitate the formation of a unique organization existed. Some of the ingredients included the need to fulfill a role of compassion, provide a center of social interaction and a means to preserve a heritage, which was so much of a part of the people arriving in the United States - full of hope and determination as they embarked upon their new lives. February 24, 1908, marked the point at which all of the ingredients were mixed to ignite the light of an organization which finds its very purpose within human compassion and the notion of the moral responsibility that each person has to look out for his or her brother. Thus, was born the Polish National Union of America, a Fraternal Benefit Society.

Throughout the records of the Polish National Union of America there are countless stories about how our beloved organization has extended the hand of human

compassion in time of need and how it has helped to further the values of education, religion, and culture at the same time. The stories are for history to tell, and they express the human concern woven into our organization's fabric such that a multitude of members could personally express how their lives have been touched.

The Polish National Union of America was and still is a very progressive and forward -thinking organization. As such from the early beginnings of its history our organizer, Prime Bishop Francis Hodur, saw fit to insure men, women and children, while most insurance companies did not, in order to help families prepare for the loss of loved ones while providing for those who remained. In 1908 adversities existed among many aspects of daily life such as disease and work-related death. Yet, the people who had the courage to start and invest their hard—earned wages in the Polish National Union of America were confident in the ideal that they had to support one another while fulfilling many of the responsibilities set before them by their faith in God and trust in Jesus Christ.

September 30, 2023, we will all be taking a step forward as we join hands with our brothers and sisters of the Polish National Alliance to continue to provide financial comfort through insurance as well as the support of one another in the fulfillment of our responsibility set before us by our Lord and Savior Jesus Christ.

On a personal note, I am very humbled by the everyday fraternalism and love expressed by the members of the PNU throughout my career as an executive officer. I often reflect on the kindness and hospitality shown to my family as travel, and meetings would mandate visiting the vast geographical area represented by our membership. I am also thankful for the support that has been shown over the past 35 years regarding the many successful endeavors undertaken during that time which helped to keep the PNU strong, steady and on course to "Join Hands to Touch Lives." When one thinks about it there is a huge WOW! Factor trying to count the number of lives touched every day by members doing fraternal work. It truly has been a privilege to work with our Prime Bishops, Bishops, members of the clergy, Officers, and Directors, Talented Staff and especially our members as the work of the PNU has been propelled into the future. May God Bless you all with Health, Happiness, and a Long Life!

Now is the time to embrace the future, step through the open door, and utilize the opportunities that God has provided to help protect our families, preserve our heritage, and Love our brothers and sisters as we would love ourselves.
