On a positive note

A Reflection By PNU CFO/ Secretary John Andrzejewski

The concept of each person being his or her brothers or sisters keeper has become very evident during the past few months as the COVID-19 Pandemic has swept across the world. We see many headlines and good stories about people coming together to help others in need. Often the concentration of help stories are about the effort to make sure people are fed and taken care of. However, once in a while a headline appears in the news that one would never expect to see.

Recently the Wall Street Journal ran an article that blazoned the headline “Life Insurers Halt Sales as Hopes for Profit Dim.” This headline took me by surprise mainly because of the fact that the main benefit offered to the members of the PNU is life insurance. The article further goes on to state, “The driving force behind the action: a collapse in interest rates tied to the spread of the coronavirus” Within the article several of the larger insurers in the country are named, however I don’t want to dwell on this news.

On a more positive note, the PNU has not stopped issuing life insurance certificates to members who apply. Tough times generally mean that common groups of people band together and get even tougher to ride out the dark days with hope, encouragement, assistance, and their faith in God that sunny days are on the horizon. Examples of these times can be found throughout the history of the PNU.

The first and foremost example is rooted in 1908 when the PNU was formed. At that time the social and economic conditions were such that members of the newly formed Polish National Catholic Church were being isolated within their communities bringing rise to the need to provide for both spiritual and financial means. During 1908 with the leadership of Prime Bishop Francis Hodur men and women came together as brothers and sisters in the form of the PNU and with the intention of providing for the protection of families through the establishment of a death benefit fund. This was the initial form of life insurance made available to our members. In the spirit of each person being their brothers and sisters keeper members contributed funds to a common pool which was held to pay a specified death benefit should another member pass away. This was a way of easing the burden upon a family should a death occur. The fund was periodically replenished through the assessment of dues to each member.

Life insurance as we know it today started to take shape in the 1920’s with formal codification or laws implemented by the various states of the United States. With the codification the dues payments made by members of the PNU became periodic premium payments made to purchase a death benefit or what is more commonly known as life insurance coverage. Despite the change the PNU continued to serve its members basic needs for death benefits and through the early part of the 20th century extended the benefit such that both women and children were eligible for enrollment for the life insurance coverage.

PNU Announces Direct Premium Payment Option

Recently the PNU established the ability to allow for premiums to be paid direct from a member's checking or savings account. This is more commonly referred to as a direct debit or ACH transaction.

Members who received their premium bills for the month of April were the first to be alerted to this new service. A form was included to complete in order to request automatic payment of premium.

The ACH option eliminates the need to either mail or physically present a premium payment at the Home Office.

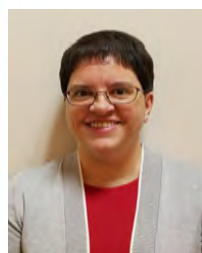

Polish National Union of America District 1 Quarterly Meeting June 3, 2020

On Wednesday, June 3, 2020, District 1 held their second quarterly meeting for the 2020 year. The meeting was held as a phone conference due to the Covid-19 pandemic. At 7:06PM, District Director Julie Andrzejewski called the meeting to order. Director Andrzejewski then called upon Prime Bishop Emeritus Swantek for the invocation.

Secretary's Report: Attendance: District Secretary Jessica Moser reported that there were 18 Delegates representing 10 branches and 1 guest present. Secretary Moser then read the minutes from the previous meeting. Director Andrzejewski asked if there were any corrections or errors and there were none noted. A motion was made by PNU Board Director Mari Jane Stankowski, seconded by Reverend Carmen Bolock to accept the minutes as read. Director Andrzejewski called for a vote. Motion passed unanimously.

Treasurer's Report: Treasurer Patricia Bolock gave the financial report from March 7, 2020 to June 3, 2020. Director Andrzejewski asked if there were any corrections or errors and there were none noted. A motion was made by Branch Secretary Dorothy Andrzejewski and seconded by Patricia Evanchyk to accept the treasurer's report. Director Andrzejewski called for a vote. Motion passed unanimously.

Training: How to Sell Insurance Policies: Director Andrzejewski proceeded on how to help our members determine what type of insurance is best for them to buy. Director Andrzejewski continued the training on insurance sales by discussing the benefits the PNU offers with each insurance policy. Vice Director Joan Scheuneman provided advice on sales for Single Premium Policies being best for children as they are cheap and lifelong. Branch Secretary Jan Cwikla also provided advice on how to approach a member, that may not expect they can afford insurance, in particular the younger generation. Board Director Mari Jane Stankowski reminded the delegates that even if your job offers life insurance, many people do not realize it is a term insurance. This can be a benefit of the PNU plans. Director Andrzejewski concluded the training by answering questions from the delegates and providing clarity on successful insurance sales.

Old Business: Children's Day at Bishop Hodur Retreat and Recreation Center: Director Andrzejewski continued into old business opening with the initial plan for Children's Day at Bishop Hodur Retreat and Recreation Center. Due to the current pandemic with Covid-19, the Children's Day event planned is placed on hold for the time being. Dine to Donate 2020: Old business discussion continued into the fundraiser for Texas Roadhouse initially planned for May 14th and May 28th. Due to Covid-19 the fundraiser planned is also currently on hold. Delegate Patricia Evanchyk recently contacted Texas Roadhouse, but due to the pandemic, is unable to get a date at this time. This too will be revisited at a later date.

New Business: Selling Insurance Contest: Director Andrzejewski opened the floor for new business. First on the agenda was a discussion about an insurance selling contest. Director Andrzejewski asked for suggestions from the delegates about possible prizes for the contest. Revered Bolock suggested gift cards to restaurants, ranging in value. Board Director Mari Jane Stankowski requested an outline before any plans were made. The contest outline will be provided by Director Andrzejewski by email in time for our September meeting. Children and Youth Stipend Program: PNU Board Member, Mary Ann Stankowski entered discussion regarding the Children and Youth Stipend program. The applications were due April 15, 2020. PNU Board Member Mary Ann Stankowski discussed she was currently creating a possible new application for the Children and Youth program, which allows more information to be added which is necessary for the process. Once approved, the applications will be forwarded to the District Directors. Board member Mary Ann Stankowski also stated due to Covid-19 typical fundraisers the Children and Youth has will be placed on hold at this time.

Home Office Updates: CFO John Andrzejewski III started the updates explaining the Covid-19 protocols for the Home office during this time had reduced hours. These hours will be changing the week of June 8th, hopefully increasing the open office hours. CFO Andrzejewski stated there has been an increase in claims due to Covid-19, but the office is staying up to date with our members' needs. CFO Andrzejewski provided an update on future training videos and presentations that soon will be added to SharePoint for District Directors and Branch secretaries. CFO Andrzejewski provided a reminder that many of our forms used in the home office are available on the website, so please direct your members to download them if needed. CFO Andrzejewski continued by stating the Branch Rosters and 990-N tax documentation has been mailed to our Directors and Branch Secretaries. As a reminder, please return these if you have not already as they are extremely important in showing how active we are.

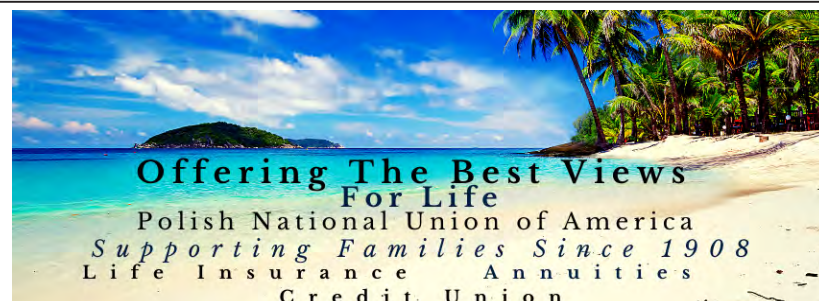

PNU Member Plays Key Role in Living Chapel Assembly (Continued from p. 6)

The purpose of the chapel is “to encourage worldwide acts of ecological restoration with an emphasis on tree planting in support of the U.N.’s Trillion Tree Campaign,” said Denny, who earned a bachelor of architecture from the Stuckeman School.

The structure, which features green walls that are adorned with living plants and an elaborate chime wall featuring metal embellishments, will officially be introduced via streaming video on June 5 in the Rome Botanical Garden as part of events organized by the Italian Alliance for Sustainable Development in celebration of the U.N.’s World Environment Day.

The chapel will eventually be on display at the Vatican, where it will become the second structure in Vatican City to be designed by an American architect. The first was the Chapel of the Holy Spirit by architect Louis Astorino, also a Penn State architecture alumnus.

From the Vatican, the Living Chapel will move to its permanent home in Assisi, Italy, as a feature point of a new Saint Francis pilgrimage trail that is being unveiled this spring.

Kalsbeek located a workspace large enough for their needs — the Laundry Building on campus — and assembled a “dream team” of students and researchers with expertise in building foundations, methods of assembly, fabrication processes, green structures and materials research that could work together to build the traveling, green, artistic, musical structure Revie and Denny envisioned.

That core team included architecture doctoral student Elizabeth Andrzejewski, graduate students Elizabeth Rothrock and Kacie Ward, and research assistants Becca Newburg, Garrett Socling and Dani Spewak, an alumna of the School of Visual Arts.

With her strong welding background, Andrzejewski focused on the fabrication and mounting of steel pan drums from the donated parts on the chime wall, which was to be the chapel’s focal point.

The original plans for the chapel called for up to 10,000 saplings, cultivated from the Botanical Garden’s own trees and other participating nurseries, to be featured on or around the chapel. The idea was that the saplings would then grow enough to cover the structure by the time the chapel was unveiled.

Since those saplings continued growing while plans for the chapel were on hold as the COVID-19 pandemic surged, they are now too mature to install on the walls and are planted in pots throughout the chapel. Those trees will be distributed upon the chapel’s public opening to be planted in other parts of Italy where deforestation has taken place.

The green walls of the chapel are adorned with 3,000 perennial plants — a mix of evergreen leaves and flowers — that form a mosaic pattern. They are affixed to the walls with recycled fleece fabric that is stapled to PVC board. Other areas of the chapel also include trees and plants to reflect the rich biodiversity of Europe’s old growth forests, which have been almost entirely lost due to deforestation. After the chapel moves to the Vatican, it will eventually make its way to its permanent home in Assisi, near the chapel built by St. Francis, patron saint for ecologists.

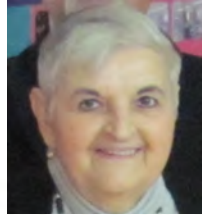


An aerial view of the Living Chapel as it stands assembled in the Rome Botanical Garden.

Chris Plewniak, EMS/ EMT Advanced/ Emergency Services Department

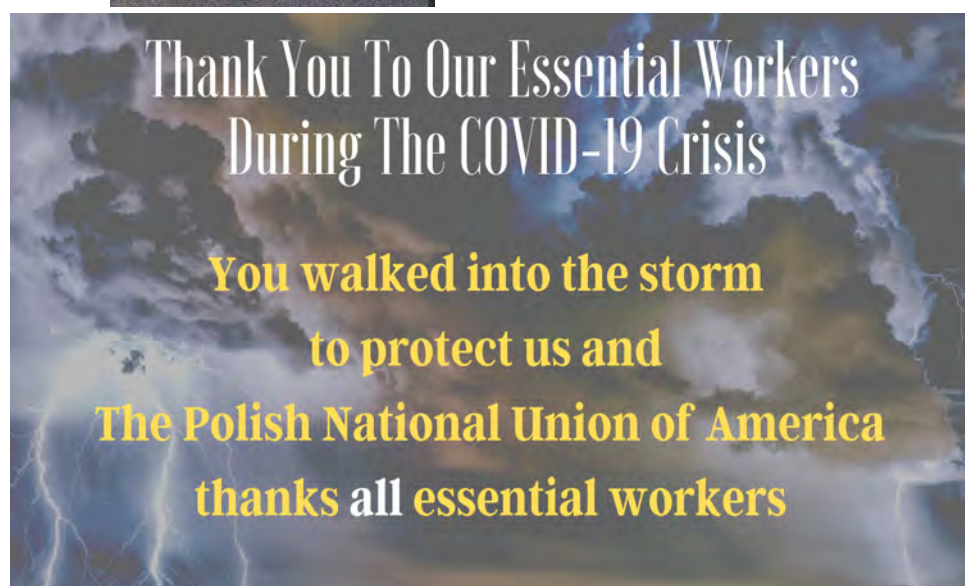

Polish National Union of America Privacy Policy Notice

The Polish National Union of America (The Society) is a member driven society, which is highly dependent upon the confidence each individual has in its purpose. One of the most essential elements of the member-society relationship is privacy. Privacy is and always has been the number one priority of The Society. Keeping with this tradition, the following notice is intended to inform you about the information the society collects in the process of providing insurances services and member benefits.

“Nonpublic personal information” (NPI) is defined as nonpublic information about you that The Society obtains in connection with providing an insurance or annuity product to you. Examples of NPI include amounts of insurance, premium payment, and beneficiary designations.

Information Collected By The Society

- A. Information submitted by you on applications for membership, insurance coverage and claims.
- B. Information submitted by you and documents associated with the many fraternal programs established by The Society, (E.G Scholarship programs and stipends).
- C. Information received by The Society for underwriting processes. This information is generally obtained from sources such as personal medical records, society required exams, and other third party consumer reporting agencies.

Information Disclosed By The Society

The Society is permitted by law to disclose NPI to nonaffiliated third parties that assist in processing of data and the servicing of accounting records for the purpose of carrying out main business. The Society is also obligated to disclose this information to government entities during periodic mandatory audits.

There are certain third party affiliates associated with the Polish National Union which from time to time NPI is shared in order to provide additional benefits to you. The third parties include The Straż , Spółnia Credit Union , Inc., Fraternal Activities Committee and The Education and Youth Committee. The Society does not disclose any NPI about you to any other third parties, except as permitted by law. Information shared is derived from that which is collected during the many application processes administered by The Society as described in the section entitled “Information Collected by the Society.”

Procedures For The Preservation of Your Privacy

As a fraternal benefit society, The Polish National Union of America has held membership privacy as its highest priority since the start of business in 1908. Since then many procedures and safeguards have been developed to ensure that this priority be maintained. Among them are:

1. Training of personnel regarding the recognition of NPI and proper authorization for release of that information.
2. Limiting record access only to those Home Office employees who are working with your file.
3. Requirements that all requests for information be signed in original with a proper witness.
4. Establishment of board policy requiring the immediate dismissal of any employee who divulges NPI without proper authorization.
5. Establishment of policy restricting the distribution of NPI to those third parties permissible by law only. Your NPI is protected by board policy which regards all information as private and therefore not for sale or for use by any nonaffiliated third parties. This policy also extends to former insureds who no longer have a customer relationship with The Society.

As a final note, please be assured that the information in our insurance files will always be available for modification, corrections, or change when appropriate.

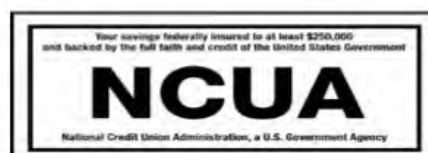

On A Positive Note (Continued from p.3)

Moving forward in time from 1908 the PNU has seen many dark days in the form of World War One, the Pandemic of 1918, various industrial and mining disasters, the Great Depression and World War II. With the advent of WW II the PNU as well as its membership stepped forward to serve the country and provide financial support to the families who paid the ultimate sacrifice with the loss of loved ones. During this time the PNU experienced member deaths which were higher in numbers due to combat deaths. What this represented was a group of members who passed away in a short period of time at an age when death was not common. There is no doubt that this scenario placed financial stress on the PNU. However, rather than leave families with a financial burden due to what is known as the War Clause the PNU membership decided to honor the death benefit claims being filed on behalf those members who were killed in combat. The answer to covering the payments was what is formally known as a special assessment. Informally, the answer turned to the beginnings of the PNU where the pool of money established to pay claims was replenished through each member contributing to the pool. In this way our members exhibited an example of each of us being our brothers and sisters keeper.

Fast forward to the present day. Another dark time has arisen with the COVID-19 Pandemic coupled with the economic fallout of ultra-low interest rates and job losses. During this time the PNU continues to serve its membership through the home office. The PNU has been operating on reduced hours and a rotation of staff since March with the hope of being able to return to a normal schedule of operation by the time this article is printed. One of the most important goals of being able to continue operating is to be able to process claims related to COVID-19 as well as those which are normally occurring in an effort to help relieve the anxiety of having lost a family member. It really is the culmination of the purpose of the PNU in that the financial burden that arises from burial costs is in some way covered thus becoming one less thing on the list of worries.

This brings me to the point of all of this. The PNU has not stopped writing benefit certificates otherwise known as life insurance policies for its membership. Since 1908 the PNU has provided a basic coverage that serves the purpose of covering burial expenses or other final expenses. What we offer is not fancy, it is not complicated and will not make one rich. Our specialty is whole life based insurance certificates issued primarily in the range of \$5,000 to \$30,000 intended to be there to offer relief from the financial burden arising from the loss of a loved one. The concept has not changed from our inception that everyone is his or her brothers and sisters keeper since the PNU is still a member owned fraternal benefit society.

My prayers go out to all of you, my brothers and sisters that you will stay safe during these dark days, that you will not have to experience the loss of a loved one as a result of the pandemic, and that should you fall ill or loose someone that you will be comforted by the Love and teachings of Our Lord and Savior Jesus Christ. There are brighter days ahead!

History of Flag Day

On May 30, 1916, President Woodrow Wilson issued a presidential proclamation establishing a national Flag Day on June 14. Many Americans celebrate Flag Day by displaying the Red, White and Blue in front of homes and businesses. The day commemorates the adoption of the Stars and Stripes as the official flag of the United States.

Do you know the flag's history? According to American legend, in June 1776, George Washington commissioned Betsy Ross, a Philadelphia seamstress, to create a flag for the new nation in anticipation of a declaration of its independence.

12 Cool Facts About the United States Flag

It was designed by a high school student

The current flag, with 50 stars and 13 stripes, was designed in 1958 by 17-year-old high school student, Robert G. Heft, of Lancaster, Ohio. President Dwight D. Eisenhower chose his design out of 1,500 entries.

Red, white, and blue

The colors of the flag have important meanings. Red symbolizes hardiness and valor, white symbolizes purity and innocence, and blue represents vigilance, perseverance and justice.

Maintenance of the flag

If a flag can no longer be used or repaired, it must be destroyed in a respectful manner, such as by burning. It can be washed and dry cleaned if it gets dirty or if it touches the ground and is soiled.

Sleep-wake schedule

According to Federal flag laws and regulations, the flag should be displayed from sunrise to sunset, except during inclement weather. It may be displayed 24 hours a day as long as it's "properly illuminated" while it's dark out.

Old Glory origins

Old Glory was the nickname of a specific U.S. Flag — that owned by sea captain William Driver. He was given the flag by his mother and other women in his hometown of Salem. He named it Old Glory upon seeing it flying on his ship's mast in 1831, and continued to display it outside his home. The name later went on to become synonymous with any American flag.

Flag Day

On May 30, 1916, President Woodrow Wilson issued a presidential proclamation establishing Flag Day as the anniversary of the Flag Resolution. On August 3, 1949, President Truman signed an Act of Congress that designated June 14 of each year as National Flag Day.

Fourth of July - Independence Day

The Fourth of July—also known as Independence Day or July 4th—has been a federal holiday in the United States since 1941, but the tradition of Independence Day celebrations goes back to the 18th century and the American Revolution. On July 2nd, 1776, the Continental Congress voted in favor of independence, and two days later delegates from the 13 colonies adopted the Declaration of Independence, a historic document drafted by Thomas Jefferson. From 1776 to the present day, July 4th has been celebrated as the birth of American independence, with festivities ranging from fireworks, parades and concerts to more casual family gatherings and barbecues.

Did you know?


John Adams believed that July 2nd was the correct date on which to celebrate the birth of American independence, and would reportedly turn down invitations to appear at July 4th events in protest. Adams and Thomas Jefferson both died on July 4, 1826—the 50th anniversary of the adoption of the Declaration of Independence.

On July 4th, the Continental Congress formally adopted the Declaration of Independence, which had been written largely by Jefferson. Though the vote for actual independence took place on July 2nd, from then on the 4th became the day that was celebrated as the birth of American independence.

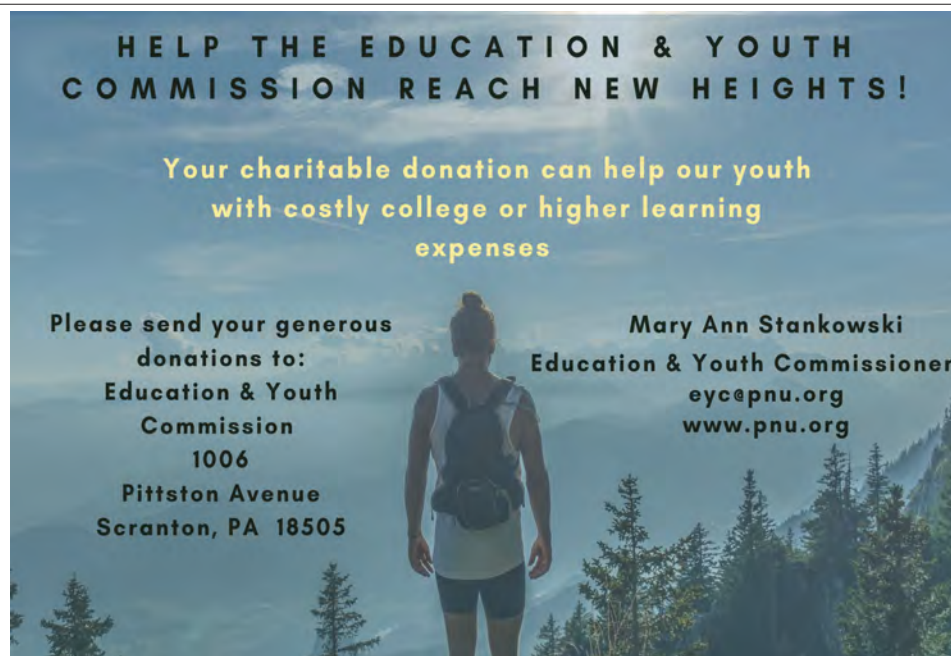
